## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of King County Fire Protection District No. 28 from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Open public meeting minutes
- Policy review
- Compliance with grant requirements
- Financial condition

King County Fire Protection District No. 28 provides emergency services to the City of Enumclaw as well as the surrounding rural plateau with combined population of more than 21,000 people over an area of approximately 50 square-miles. Fire and emergency medical services are provided from three fire stations. The District has an operating budget of approximately \$3 million annually.
