AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Department operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Enumclaw Fire Department from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Department's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance – unemployment
- Credit card expenditures – policy, procedures, and credit card activity
- Interlocal agreements – compliance with agreement requirements
- Small and attractive asset tracking
- Open public meeting minutes
- Financial condition and fiscal sustainability

INFORMATION ABOUT THE DEPARTMENT

The Enumclaw Fire Department, formerly known as King County Fire Protection District No. 28, provides emergency services to the city of Enumclaw as well as the surrounding rural plateau with combined population of more than 21,000 people over an area of approximately 56 square miles. Fire and emergency medical services are provided from three fire stations. The Department has an operating budget of approximately \$4 million annually.

The Enumclaw Fire Department operates under the legislative authority of five Fire Commissioners, each elected by the citizens of the city and the district.
