A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE ENUMCLAW FIRE DEPARTMENT TO TRANSFER ADDITIONAL FUNDS IN THE AMOUNT OF \$1,325,000.00 FROM THE ENUMCLAW FIRE EXPENSE FUND 100280010 TO THE CAPITAL OUTLAY FUND 100283010.

WHEREAS, the Board of Commissioners of the Enumclaw Fire Department desire to enhance the financial integrity of the Fire District; and

WHEREAS, the enhancement of financial integrity requires adequate funding of the Capital Outlay Fund for funds to be available for future capital outlays; and

WHEREAS, the Capital Outlay Fund is of benefit to public health, safety and welfare; and

WHEREAS, the Board wishes to transfer an additional \$1,325,000.00 from the Expense Fund 100280010 to the Capital Outlay Fund 100283010 to sufficiently fund the Capital Outlay budget in future years; and

Section 1: The Board of Commissioners of Enumclaw Fire Department do hereby transfer \$1,325,000.00 from the Enumclaw Fire Expense Fund 100280010 to the Capital Outlay Fund 100283010.
