RESOLUTION #2022-02**

A RESOLUTION BY THE BOARD OF COMMISSIONERS OF ENUMCLAW FIRE DEPARTMENT, KING COUNTY FIRE PROTECTION DISTRICT #28, AMENDING THE 2022 CAPITAL OUTLAY BUDGET TO FACILITATE THE PURCHASE OF EQUIPMENT IN THE AMOUNT OF \$275,000.00.

WHEREAS, the Fire District budgeted \$399,000.00 in 2021 to purchase two new utility trucks and a brush truck; and

WHEREAS, due to supply chain issues the Fire District was unable to complete the purchases of all equipment budgeted in 2021; and

WHEREAS, the Capital Outlay budget for machinery & equipment had \$289,659.16 remaining budgeted funds in 2021; and

WHEREAS, the Board of Commissioners desires to rollover \$275,000.00 of the 2021 unexpended funds and amend the 2022 Capital Outlay budget in order to reflect fiscal responsibility.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF ENUMCLAW FIRE DEPARTMENT, KING COUNTY, WASHINGTON DO HEREBY RESOLVE AS FOLLOWS:


Section 1: The 2022 Capital Outlay budget for machinery and equipment shall be and is hereby amended to include an additional \$275,000.00.
