

**COST SHARING  
MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding is entered into between the undersigned municipal corporations collectively referred to as Agencies.

**RECITALS**

1. The Agencies collectively applied for and received a grant to fund the first year of licensing the PulsePoint program to benefit the Agencies and the citizens they serve.
2. The goal of the implementation of PulsePoint is to increase CPR survivability within Zone 3.
3. King County Fire Protection District No. 28 is serving as the Lead Agency and will enter into the necessary licensing Agreement with the PulsePoint Foundation.
4. The Parties wish to share in any future costs associated with continuing the PulsePoint Licensing beyond the one-year initial license.

**AGREEMENT**


To carry out the purposes of this Agreement and in consideration of the benefits to be received by each party, it is agreed as follows:

**1. Payment Obligations.**

- 1.1.** In the event additional grant funding is not received, the Agencies agree to share equally in the cost of future PulsePoint Licenses. The cost of the annual license is currently \$25,500. Cost sharing shall be allocated based on the number of each participating Agencies full time personnel as shown in **Exhibit A** or as adjusted each year based on participating Agencies and personnel numbers existing on January 1 of each year.
  - 1.2.** The Lead Agency shall provide notice to the other Agencies of the annual cost of the annual license at least 90 days in advance of the license renewal date "Notice Date." Each Agency shall have the option to opt out of the cost sharing by providing the Lead Agency written notice of such decision within 30 days of the Notice Date.
  - 1.3.** The Lead Agency shall invoice each Agency for its share of the license cost based on the number of participating Agencies within 30 days of receiving an invoice from the PulsePoint Foundation.
- 2. Term.** This Agreement shall be effective on the date more than two Agencies have executed this Agreement and shall remain in force if at least two Agencies remain parties to the Agreement. An Agency may withdraw from this Agreement on 30 days advance written notice. A withdrawing party shall be responsible for its share of the annual license cost for the following year if notice of withdrawal is provided more than 30 days after the Notice Date identified in Section 1.2.

3. **Entire Agreement.** The entire agreement between the parties hereto is contained in this Agreement and this Agreement supersedes all of their previous understandings and agreements, written and oral, with respect to this transaction. This Agreement may be amended only by written instrument executed by the parties subsequent to the date hereof.
4. **Multiple Counterparts.** This Agreement may be executed in any number of counterparts, each of which shall constitute an original, and all of which will together constitute this one Agreement.
