RESOLUTION #2023-09**

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE ENUMCLAW FIRE
DEPARTMENT AMENDING THE SCHEDULE OF FEES FOR BLS TRANSPORT SERVICES.**

WHEREAS, the Enumclaw Fire Department adopted Resolution #11-004 and began billing for BLS transport services in July 2011; and

WHEREAS, the billing rate charged by other jurisdictions was reviewed by the Board of Commissioners of the Enumclaw Fire Department; and

WHEREAS, the Enumclaw Fire Department's billing rate charged for BLS transport services is significantly below other jurisdictions; and

WHEREAS, the Board of Commissioners of the Enumclaw Fire Department desires to amend the fee schedule for BLS transport services and increase the billing rate to recover costs beginning January 1, 2024; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
ENUMCLAW FIRE DEPARTMENT, KING COUNTY, WASHINGTON DO HEREBY RESOLVE
AS FOLLOWS:**

Section 1. Rates:

- (a) For Basic Life Support transport provided by or on behalf of the Enumclaw Fire Department, the rate per patient call is hereby approved and shall be \$1,100.00, plus mileage at \$20.00 per mile.
- (b) Any costs levied against the Department by other agencies or companies.

Section 2. Economic Circumstances:

All BLS transport rates, fees and charges including, but not limited to, those adopted in this resolution shall be increased by 100% of the Urban Wage Earner and Clerical Workers Index (CPI-W) for the Seattle-Tacoma-Bellevue area for the period June through June as provided by the Bureau of Labor Statistics each calendar year on January 1st. Provided, the Board may by resolution determine, in the exercise of its discretion, not to apply or impose such annual increase in any calendar year if economic circumstances (including revenues and expenditures) allow. Such a resolution shall not operate as a waiver of the automatic annual increase in any subsequent calendar year, as set forth above.
