**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE ENUMCLAW FIRE DEPARTMENT
TO AMEND AND ADOPT THE ENUMCLAW FIRE DEPARTMENT'S FEE SCHEDULE.**

WHEREAS, the Board of Commissioners of the Enumclaw Fire Department adopted Resolution #2015-019 in October 2015 to establish a fee schedule; and

WHEREAS, the fees set forth on Exhibit "A" are based upon the estimated time and associated costs to provide the service for which the fee was established; and

WHEREAS, the Board of Commissioners of the Enumclaw Fire Department desires to amend the fee schedule annually to update fees associated with recovering costs for services.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF ENUMCLAW FIRE DEPARTMENT, KING COUNTY, WASHINGTON DO HEREBY RESOLVE AS FOLLOWS:

Section 1: That the Fee Schedule, attached as Exhibit "A" and incorporated by reference is hereby amended and adopted.

Section 2: That the Fire Chief shall have the authority to adjust the adopted fee schedule annually without further authorization of the Board, unless specifically required by supporting Resolutions.

Section 3: If any fee or provision of this Resolution is invalid or unenforceable for any reason, the remaining shall be in force and effect.
