**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE ENUMCLAW FIRE
DEPARTMENT TO TRANSFER IMPACT FEE REVENUE IN THE AMOUNT OF
\$2,377,132.55 FROM THE ENUMCLAW FIRE CAPITAL OUTLAY FUND 100283010
TO THE SPECIAL REVENUE FUND 100283020.**

WHEREAS, the Board of Commissioners of the Enumclaw Fire Department desire to enhance the financial integrity of the Fire District; and

WHEREAS, the enhancement of financial integrity requires adequate separation of Impact Fee Special Revenue funds from the Capital Outlay funds to allow for proper tracking and spending of impact fee revenues; and

WHEREAS, the enhancement of financial integrity requires adequate separation of Capital Outlay funds from Impact fee Special Revenue funds to be available for future capital outlays that may not be able to be funded by the use of impact fees, including those impact fees previously collected; and

WHEREAS, the Special Revenue Fund benefits public health, safety and welfare; and

WHEREAS, the Capital Outlay Fund benefits public health, safety and welfare; and

WHEREAS, the Board wishes to transfer \$2,377,132.55, which represents the total impact fees and interest thereon collected after impact fees were first authorized in 2017, plus any additional interest earned on this amount after May 1, 2025, from the Capital Outlay Fund 100283010 to the Special Revenue Fund 100283020 to separate Impact Fee funds from Capital Outlay funds; and

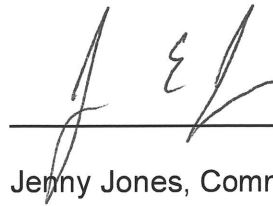
WHEREAS, the Board desires to reconcile the Capital Outlay Fund and the Impact Fee Special Revenue Fund based on a review of prior expenditures to accurately account for expenses attributable as Impact Fee funds.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
ENUMCLAW FIRE DEPARTMENT, KING COUNTY, WASHINGTON DO HEREBY
RESOLVE AS FOLLOWS:**

Section 1: The Board of Commissioners of Enumclaw Fire Department do hereby transfer \$2,377,132.55 plus any additional interest earned on this amount after May 1, 2025, from the Enumclaw Fire Capital Outlay Fund 100283010 to the Special Revenue Fund 100283020.

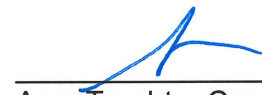

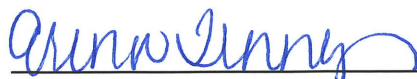
