RESOLUTION #2025-08**

**A RESOLUTION BY THE BOARD OF COMMISSIONERS OF ENUMCLAW FIRE
DEPARTMENT, KING COUNTY FIRE PROTECTION DISTRICT #28, RESCINDING
RESOLUTION #09-004 AND AUTHORIZING THAT NO FEE BE CHARGED FOR
RESIDENTIAL BURN PERMITS.**

WHEREAS, RCW 52.12.101 confers on fire protection districts the authority to adopt and publish a resolution authorizing the issuance of burning permits under such terms and conditions as the district establishes.

WHEREAS, the Board of Commissioners of King County Fire Protection District No. 28 properly established a burning permit system pursuant to Resolution 09-004 and RCW 52.12.101 through 52.12.108 in 2009.

WHEREAS, the Board of Commissioners intends to continue the burning permit system but desires to waive the associated permit fees.

**NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF COMMISSIONERS OF
ENUMCLAW FIRE DEPARTMENT, KING COUNTY, WASHINGTON, THAT THE DISTRICT
SHALL CONTINUE TO EXERCISE THE AUTHORITY TO ISSUE BURNING PERMITS UNDER
THE PROVISIONS OF RCW 52.12.101 THROUGH 52.12.108 AS ESTABLISHED UNDER
RESOLUTION #09-004.**

**IT IS FURTHER RESOLVED BY THE BOARD OF COMMISSIONERS, THAT PERMITTEES
SHALL NOT BE CHARGED FOR OBTAINING REQUIRED BURN PERMITS AND THE CHIEF
OF THE DISTRICT IS AUTHORIZED AND DIRECTED TO MAINTAIN AND REVISE THE
RULES AND REGULATIONS GOVERNING THE ISSUANCE AND REVOCATION OF
BURNING PERMITS AND THE TERMS AND CONDITIONS UNDER WHICH BURNING
PERMITS WILL BE AUTHORIZED.**
